Consideration of Proposals Requested from Vivicon

Mr. Parris presented and reviewed the proposals received from Vivicon for sod installation at various areas, plants at the amenity center and to flush cut trees at the Amenity Center. He stated that Mr. Brown recommends all five of the proposals.
